#### Jurisdiction

The competition shall be held under the National Sporting code, the Environmental code and standing regulations of the ACU, these Supplementary regulations, which shall be submitted to the ACU and any written instructions, which may be issued relating to the event.

#### Eligibility

This event is open to riders who hold a valid ACU or SACU license or Trials registration. Riders must also be a member of the GMC&CC; overseas riders, a 2-day membership is included in the entry fee. The event is open to solo machines only.

For senior/adult riders they must also hold a current driving license for the machine they enter.

For juniors the event is open to any junior who is able to ride at least novice route and is on a 125cc or upwards machine. You will need to be transported from section area to area and will be permitted to ride the sections consecutively. Transport can be provided if required.

Foreign riders must have a current license and Start Permission from their own Federation and proof of FIM cover.

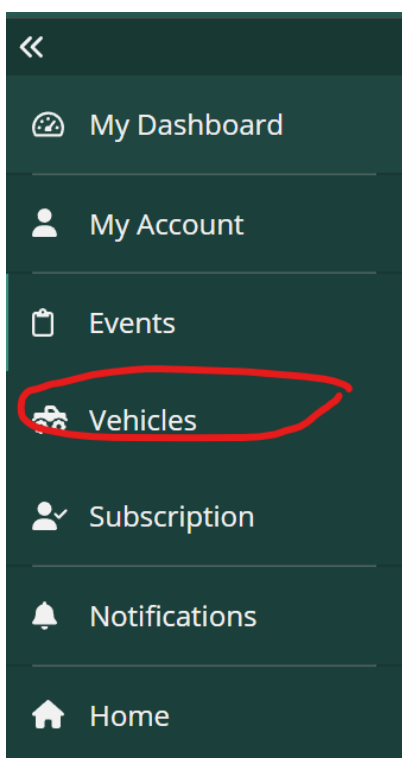
#### Entries

The entry list will be limited to a maximum of 100 riders accepted in order of receipt. Entries must be completed online at the following link: <https://www.gmccc.gg/events>. Please find the event entitled '2 day trial' on 23/03/2024.

**Overseas riders please read and follow the following instructions carefully to assist with completion of your entry form.**

- If not done so before, you will first need to create an account on the club website (as linked above) with an email and password. If enrolling for a junior, please make sure you enrol them in their own name and not yours.
- Once you have done so please then email the club secretary, Sandra Le Page at [compsecretary@gmccc.gg](mailto:compsecretary@gmccc.gg) stating you are an overseas rider for the event and she will then override so you are able to enter the event without paying the club membership fee. For the avoidance of doubt you **do not** need to pay the membership of £70 or insurance of £20 to enter this event.
- **OR** If you already have an account from prior year you can login again.

- Once the club secretary has overridden you as a overseas member (if required) you will be able to enter the event by following the ‘Sign up’ link for the ‘2 Day Trial’ on the events page. Then follow the following instructions:
  1. Click on the ‘Entrant Sign up’
  2. If you are entering an event for the first time you will need to add a ‘Vehicle’ using the option on the left hand side of the screen. See screenshot:



3. Fill in the details as required. Race Number is a mandatory field but please just insert any number. License number should be your ACU or FIM licence number and please select the appropriate trials licence you hold (Trials – Adult, Trials – Youth A, Trials – Youth B, Trials – Youth C, Trials – Youth D, Trials – Youth E).
4. Once you have saved your vehicle and details this option should then appear on the ‘Vehicle’ drop down menu.
5. Class is as per the routes offered. If you are entering for a junior, please select the route accordingly with ‘junior’ in the name.
6. Then click on ‘I have read and agree to the Declaration and Final Instructions for this event’. (Note: Final instructions including confirmation of starts times and pits will be sent closer to the event) and then click ‘Continue’.
7. Follow the website to confirm billing address and input payment details.
8. You will receive an email confirmation shortly after.

Entries must be received no later than **Friday 15<sup>th</sup> March 2024**.

Please note it is the rider’s responsibility to complete the entry form correctly.

### **Technical Inspection**

All machines must be ready for examination in the pits not less than 30 minutes prior to the start. All competitors must ensure that their machines are compliant with the Guernsey road traffic act, the responsibility for which rests solely with the rider.

### **Signing On**

All competitors must sign on and collect their numbered bib no less than 30 minutes before the scheduled start. ACU license, trials registration and start approval (if applicable) must be shown. If you wish to enter a team for the 'Best Team' award please do so at this time – any 3 riders, any route permissible.

### **Course/Route**

For adults: The trial each day shall consist of a maximum of 20 sections and 3 laps.

For juniors: The Saturday will consist of a maximum of 20 sections and 3 laps. The Sunday will consist of up to 15 sections and 3 laps (reduced sections compared to adults due to more beach sections where a driving license is required).

The trial shall consist of a mixture of land and beach sections. Sections will be marked accordingly:

**Expert:** Red Arrows

**B+:** Red/Blue Arrows (mixture of expert and clubman sections depending on what is indicated on the start card)

**Clubman:** Blue Arrows

**Novice Premier:** Blue/Green Arrows (mixture of clubman and novice sections depending on what is indicated on the start card)

**Novice:** Green Arrows

This trial includes the use of public highways. The route shall be clearly marked by arrows. The competitors must follow this route in its entirety and sections must be ridden in the correct sequence as per start order (unless otherwise agreed for juniors), competitors failing to do so will be excluded.

This event is routed along and across public rights of way competitors must exercise caution and reduce their speed accordingly near other users. Be especially careful near horses slow down stop and cut your engine. The island speed limit differs from 15mph to a maximum of 35mph. All riders must adhere to these limits at all times.

### **Method of Marking**

TSR 22 - Stop permitted.

All observers decisions are final. Please do not argue with an observer. They give their time free of charge and stand in the cold for hours on end so our event can go ahead so please be extra courteous.

### **Crash Helmets**

Riders must always wear crash helmets when riding their machines.

## **Insurance**

Third party insurance is necessary by law to meet road traffic requirements, and this is the sole responsibility of the competitor.
